4. All applications must be accompanied with the *Curriculum Vitae* of the applicant and key members of the Company/Firm (in the case of an organization).
5. All applicants should indicate on the application form the projects they are currently providing services for.
6. Please note that if a Consultancy application is approved, it will be prepared and registered in the name of the consultant and or firm who has committed to the requirements by doing so. In the event that the consultant and or firm would like to void their registration, kindly indicate this to the EPA in writing.

7. The applicant, upon completion of the form, should affix his/her signature and the date on the declaration page attached. Additional information may be requested if the EPA deems it necessary.
