Operation of a Sawmill

Mr. Ramdeo Persaud, trading and operating under the name, 'R. Persaud Sawmill', hereinafter referred to as the "Permit Holder", is hereby authorised in accordance with the Environmental Protection Act, Cap. 20:05, Laws of Guyana, the Environmental Protection (Amendment) Act, 2005, and the Environmental Protection (Authorisations) Regulations, 2000, to operate a Sawmill, located at Track RP, and RP1, East Amelia's Ward, Mackenzie, Linden, hereinafter referred to as the "Project", in the manner indicated in the renewal Application submitted on September 30, 2019, subject to the terms and conditions set forth herein under the Environmental Protection Act, any forthcoming regulations made under the said Environmental Protection Act and/or any other applicable laws, best practices, guidelines and standards relevant to this project.

This Operation Permit (Renewed) is issued pursuant to the Environmental Protection (Authorisations) Regulations, 2000.

Terms and Conditions for Operation to be adhered to by the Permit Holder, His Servants, Agents and/or Sub-Contractors:

1.0 OPERATION

- 1.1 Notify the Agency in writing of any proposed changes in operation of the Sawmill at least **fourteen (14) days before** making the change. The notification shall contain a **description of the proposed change in operation**. It is not necessary to make such a notification if **an Application to vary** this Permit has been made and the Application contains a description of the proposed change. In this condition **'change in operation'** means a change in the nature or functioning, or an extension, of the installation, which may have consequences for the environment, including but not limited to the following:
 - i. Changes in construction, structure, layout of the facility;
 - ii. Installation of new and/or changes to equipment, machine, apparatus, mechanism, system or technology serving the facility or operation;
 - iii. Any technology installed at the facility from which effluent may be discharged; and
 - iv. Any other circumstance or condition prescribed by Regulation 20(3) of the Environmental Protection (Authorisations) Regulations.
- 1.2 Ensure that Fire Safety Certificate is renewed yearly and all firefighting equipment are maintained and serviced regularly. The Fire Safety Certificate should be submitted upon request by EPA officers during Compliance Inspections and included in the **Annual Reports** required by **Condition 6.3.**
- 1.3 Provide adequate fire protection measures such as fire extinguishers and sand buckets in accordance with the Guyana Fire Service (GFS) approval.
- 1.4 Ensure that adequate provisions are in place for ingress to and egress from the site.
- 1.5 Maintain suitable storage facilities (racks and shelves) for all items. These facilities must be organised so that free and adequate passage is maintained. At all times ensure that there is no over-crowding of the Sawmill and/or over-stacking of lumber.
- 1.6 Maintain all internal access roads leading to the Sawmill. Fill in ruts and holes that develop during road use. Use a suitable material (such as compacted fill), and fill as soon as possible to reduce the potential for erosion.
- 1.7 Where the land surface has been disturbed during/after construction, expansion, modification or repair of the Sawmill or any portion of the Sawmill, the Permit Holder shall reclaim/rehabilitate the surface of unused land to equivalent capability.

- 1.8 Ensure that trucks are equipped with the necessary reflecting signage to warn the public of impending danger of parked/moving trucks with logs on the public thoroughfare.
- 1.9 Ensure that the transportation of logs and lumber to and from the operation does not impede road traffic. Logs and lumber must be contained within the boundaries of the project site.
- 1.10 Loading and offloading of lumber and logs shall take place between **06:00h to 18:00h** to minimise disturbance to residents.
- 1.11 Discharge logs safely through the use of appropriate equipment i.e. log extractor at the Sawmill to ensure logs do not free fall from haulers to the ground causing vibrations, excessive damage to soils and/or vegetation and nuisances to nearby residents.

2.0 EMPLOYEES AND OCCUPATIONAL HEALTH AND SAFETY

- 2.1 All employees must be equipped with and trained in the use of personal protective equipment (PPE) to fit their job specification such as: chaps for chainsaw operators, high-visibility vests, respirators, hard hats, gloves, and appropriate footwear. Employees must ensure appropriate utilisation of these gears. A log for the distribution of Personal Protective Equipment to employees must be maintained and made available to the EPA upon request and submitted in the **Annual Report** required by Condition 6.3.
- 2.2 A first aid kit equipped in accordance with the Guyana Red Cross standards must be located onsite at times. The kit must include in its contents a snake bite kit. Additionally, communication and transportation systems must be in place to respond to emergencies.
- 2.3 Ensure that all employees are trained in the use of the fire extinguishers and firefighting protocols.
- 2.4 Make all employees/third party contractors aware of the conditions of this Operation Permit and provide training on good environmental management practices. Prepare and maintain a training file for employees which should be available to the EPA upon request during Compliance Inspections.

3.0 WASTE MANAGEMENT

- 3.1 Maintain good housekeeping, sanitary and hygienic practices, and the good aesthetic quality of your surroundings at all times.
- 3.2 Ensure effective management of recoverable materials and all waste generated by the project.

- 3.3 Promote proper solid waste management practices at the site. Covered garbage receptacles must be placed at strategic locations, both in and outside of sawmill. All solid waste collected in these receptacles must be disposed of at an approved waste disposal facility. Reuse, recycle and/or compost waste materials as far as practical.
- 3.4 Maintain an enclosed dust containment bin with the capacity to store approximately seventy-five (75%) percent of all wood waste (sawdust and shavings, etc.) during a typical year. The containment bin must be designed to prevent the dispersion of any wood waste into the environment and/or atmosphere.
- 3.5 Remove sawdust from the mill floor in a timely manner. Sawdust should not be allowed to accumulate to more than 15 cm (6 inches) on the mill floor at any given time.
- 3.6 Maintain the dust extraction system to ensure there is no escape of fugitive dust. Wet suppression methods such as sprinklers should be employed where practicable to control fugitive dust.
- 3.7 Dispose of any additional unused sawdust, wood shaving, wood ends and any other solid waste at an approved waste disposal site. In the event that sawdust, wood shavings and wood ends accumulate on site, it should be kept in heaps not exceeding two (2) metres in height at a designated location and appropriately mitigated to prevent dispersion which may cause pollution.
 - 3.7.1 Options for reuse include but are not limited to:
 - a. Poultry Bedding.
 - b. Mulching.
- 3.8 Ensure that the wood waste removed from the containment bin is placed in large polystyrene bags and tightly secured before disposal at an approved landfill/solid waste disposal site.
 - 3.8.1 Waste Management Records including Disposal Manifest (information with regards to time, quantity and method of disposal, Disposal Company used and site of Disposal) must be included in the Annual Report.
 - 3.8.2 The Manifest should be used for every disposal activity and should be signed by Disposal Site Managers and the Disposal Company Manager.
- 3.9 Maintain a septic tank system at all times which should be accessible for cleaning and de-sludging. Any modification to the septic tank (s) must be in accordance with the Guyana National Bureau of Standards (GNBS) *Code of Practice for the Design*

4.0 HAZARDOUS MATERIALS/WASTES MANAGEMENT

- 4.1 Comply with the provisions of the Environmental Protection (Hazardous Waste Management) Regulations, 2000 as follows:
 - 4.1.1 There shall be no release of any pollutants (i.e. fuel, waste oil, wood preservatives) to ground water or soil from the permitted installation. Any accidental release of pollutants to soil and ground water must be recorded and reported within twenty-four (24) hours to the Agency for further investigation.
 - 4.1.2 Take the necessary precautionary measures, such as, leak-proofing of containers used for the transport of fuel to Project site. Appropriate measures should also be taken during the handling and use of all Hazardous Waste at Project site.
 - 4.1.3 Store waste oil in tightly covered drums or barrels to avoid spillage. It is an offence to drain fuel/lubricants including waste oils of any quantity from equipment onto the ground, drains or in water ways.
 - 4.1.4 Promote the reuse of waste oil, for example, as lubricant for equipment, where practical.
 - 4.1.5 Waste oils, used batteries, oily rags, filters and oil containers must be appropriately labeled, and stored in a containment bund with an impervious surface until such time for reuse or sale to an authorised dealer.

5.0 AIR QUALITY AND NOISE MANAGEMENT

- 5.1 Comply with the provisions of the Environmental Protection (Air Quality) Regulations, 2000 and the Environmental Protection (Noise Management) Regulations, 2000.
- 5.2 Comply with the Guyana National Bureau of Standards (GNBS) Guidelines for noise emission into the environment, not exceeding the limits below at a distance of 15m (50 ft) from the source or property boundary, whichever is closer.
 - Industrial Limits 100 dB (Day-time (06:00 h 18:00 h))
- 5.3 Ensure all equipment and machinery are placed on foundations properly designed to ensure effective damping of vibrations.

- 5.4 Implement all possible measures such as, ensuring equipment is serviced and operated according to manufacturer's recommendations to minimise the impact of sound levels on the environment.
- In addition to the requirements of this Permit, take all reasonable precautions to prevent wood dust from becoming airborne.

COMPLIANCE MONITORING AND REPORTING 6.0

- 6.1 Comply with any lawful directions given by the EPA from time-to-time in furtherance of the implementation of any international or other obligation for the environmental protection of Guyana.
- 6.2 Monitor the implementation of the conditions of this Operation Permit, insofar as they involve adherence by your employees and all third parties under your direction.
- Submit to the EPA, the Environmental Annual Reports on the status of the project, progress of the implementation of the monitoring activities and compliance with the conditions contained herein by **March 31** every year.
- 6.4 Comply with all terms and conditions under which this Operation Permit (Renewed) is granted.
- Permit Holder shall be liable for any loss or damage which arises from the project as a result of the Permit Holder's activities or breach of any term or condition of this Permit.
- 6.6 Inform the Agency prior to or within thirty (30) days of any change of name or ownership of the operation.
- 6.7 Notify the Agency within twenty-one (21) days in event of death, bankruptcy, liquidation or receivership of the Permit Holder or if the Company becomes a party to an amalgamation.
- 6.8 Notify the EPA within one (1) hour of the occurrence of any environmental emergencies such as a sudden onset disaster, accident, natural, technological or human induced factors that cause or threaten to cause severe environmental damage as well as harm to human health or livelihood.
- 6.9 Report to the Agency any non-compliance with the Operation Permit as follows:
 - 6.9.1 Within twenty-four (24) hours of the time the Permit Holder becomes aware of the non-compliance, submit the anticipated manner in which it may endanger human health or the environment.
 - 6.9.2 Within seventy-two (72) hours, submit to the Agency a written report containing a description of the non-compliance, its cause and the period of non-compliance including exact dates and time.

> 6.9.3 Submit a report to the Agency indicating the reasons and the anticipated time it is expected to continue if the non-compliance has not been corrected.

INSTITUTIONAL AUTHORITY/LIABILITIES 7.0

- The EPA reserves the right to conduct regular inspections of the Permit Holder's operation as part of its monitoring and enforcement requirements under the Environmental Protection Act, Cap. 20:05, Laws of Guyana, and the Environmental Protection Regulations, 2000.
- 7.2 The EPA reserves the right to review and/or amend the conditions and fees attached to this Permit, in consideration of any changes in standards, compliance with the legislation or an amended fee structure as may be determined by the Agency for projects of this nature.
- The EPA shall have the right to cancel or suspend this Permit for breach of any of the terms and conditions contained herein.
- The Permit Holder shall, at all times, allow entry to the Permitted facility to any Officer designated by the EPA for the purposes of conducting inspections or any other legitimate business of the Agency. Pursuant to Section 38 of the Environmental Protection Act, Cap. 20:05, Laws of Guyana, it is an offence to assault, obstruct or hinder an authorised person in the execution of his/her duty under the said Act or its Regulations and the Permit Holder shall be liable to penalties prescribed under paragraph (c) of the Fifth Schedule for doing so.
- This Operation Permit is not the final consent; all relevant permissions should be obtained and maintained from other regulatory bodies for continued operation.
- The Permit Holder, his Servants, Agents and/or Sub-Contractors shall be strictly jointly and severally liable as follows:
 - a. For any activity that causes, or is likely to cause pollution of the environment, unless the person takes all reasonable and practicable measures to prevent or minimise any resulting adverse effect, in accordance with Section 19(1)(a) of the Environmental Protection Act, Cap. 20:05, Laws of Guyana.
 - b. For any activity which results in the discharge, release or entry into the environment of any contaminant in any amount, concentration or level in excess of that prescribed by the regulations or stipulated by this Permit, in accordance with Section 19(1)(b) of the Environmental Protection Act, Cap. 20:05 Laws of Guyana.

- c. The discharge or release of contaminants, such as wood wastes, saw dust, hydraulic fluids, lubricants, fuel, or other industrial fluids relative to the Project, which are not authorised herein, or by Regulations under the Environmental Protection Act, are strictly prohibited. Any such discharge or release shall be deemed a violation of Section 19(1)(a) and/or (b) of the Environmental Protection Act, Cap. 20:05, Laws of Guyana.
- d. For the compensation of any Party who suffers any loss or damage as a result of the project. (Section 19(3)(e)) Environmental Protection Act, Cap. 20:05, Laws of Guyana)
- e. For any material or serious environmental harm caused by pollution of the environment intentionally or recklessly in accordance with section 39 (1), (2), (3) and (4) of the Environmental Protection Act, 20:05, Laws of Guyana.
- f. Any gross negligence or willful misconduct resulting in serious risk, or adverse effects to the environment, biodiversity, protected species and natural habitat with respect to any release or discharge, spill, contaminant fluids, oil, or lubricants from any facilities permitted under this project.
- g. For the payment of all costs and expenses related to the assessment of damage and investigations required, as result of any pollution incidents attributable to the activity for which this Permit has been issued.
- 7.7 The EPA shall notify the Permit Holder immediately of any written claim or notice sent by any complainant seeking loss or damage for negligence as a result of the Permit Holder's lack of due care and diligence.
- 7.8 Where it appears to the Agency that the Permit Holder is engaged in any activity that may pose serious threat to natural resources or serious pollution of the environment or any damage to public health, the EPA may issue to the Permit Holder a Prohibition Notice Order to immediately cease the offending activity, in accordance with Section 27 of the Environmental Protection Act, Cap. 20:05, Laws of Guyana.
- 7.9 Should the Permit Holder contravene or is likely to contravene any condition of this Permit, the EPA may serve on him an Enforcement Notice in accordance with Section 26 of the Environmental Protection Act, Cap. 20:05, Laws of Guyana.
- 7.10 This Operation Permit is effective for the period stipulated herein **November**, **2020 to October**, **2025**. This Operation Permit shall remain valid until **October**

- 7.12 Any late submission of renewal application after the specified date as stated above, shall require the Permit Holder to pay, in addition to renewal fee, a late penalty fee (accruing at the time such obligation was first owed for renewal) at a rate of **two thousand dollars (GY\$2000.00) per day** for every day late, until such renewal application is submitted to the Agency, without prejudice to any other rights of the Permit Holder in connection therewith.
- 7.13 Failure to comply with the requirements of this Permit shall render the Permit Holder liable to prosecution and to penalties prescribed under the Environmental Protection Act, Cap. 20:05, the Environmental Protection (Amendment) Act, 2005, and the Environmental Protection Regulations, 2000, including civil penalties and injunctive relief.
