



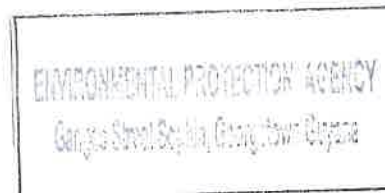

**Re: Environmental Permit (Renewed) to undertake Logging activities within the Logging Concession SFA Bce 20/08**

The Environmental Protection Agency (EPA) has prepared an Environmental Permit for you to undertake logging within the Logging Concession SFA **Bce 20/08** located at Right Bank Berbice River, Left Bank Wikki River.

Please sign the Environmental Permit to indicate your acceptance of its terms and conditions and agreement to comply with the statutory requirements of the Environmental Protection Act, Cap. 20:05, Laws of Guyana, the Environmental Protection (Amendment) Act, 2005, and the Environmental Protection (Authorisations) Regulations, 2000.

The cost for the Environmental Permit is **US \$300 for three (3) years (i.e., US \$100 per year)**. You are required to pay this fee or its equivalent in Guyana dollars, using the Bank of Guyana daily exchange rate. Payment can be made to the Environmental Protection Agency in Cash, Wire Transfer, Manager's Cheque, or Personal Cheque in Guyana dollars. Please note that a Personal Cheque written in United States dollars will NOT be accepted.

**Activity:** To undertake Logging activities within SFA Bce 20/08

Mr. Ameer Niron Bacchus, trading and operating under the name A & Z Timber Products hereinafter referred to as the "Permit Holder", is hereby authorised in accordance with the Environmental Protection Act, Cap. 20:05, Laws of Guyana, the Environmental Protection (Amendment) Act, 2005, and the Environmental Protection (Authorisations) Regulations, 2000, to undertake logging within SFA Bce 20/08, located at Right Bank Berbice River, Left Bank Wikki River hereinafter referred to as the "Project", in the manner indicated in the Application for Renewal submitted on May 16, 2022, subject to the terms and conditions set forth herein and any existing or forthcoming regulations made under the said Environmental Protection Act and/or any other applicable laws, best practices, guidelines and standards relevant to this project.

This is a Renewal of the Operation Permit Reference No.: 20210205-ANBLG, issued on June 2021 which had expired on May 31, 2022. This Environmental Permit (Renewed) is issued pursuant to the Environmental Protection (Authorisation) Regulations, 2000.

## **1.0 OPERATION**

- 1.1 The Permit Holder shall make an application to the Agency to vary this Environmental Permit in instances where it becomes necessary to:
- i. Change the construction, operation, structure, or layout of the facility and all associated buildings;
  - ii. Change equipment, machine, apparatus, mechanism, system, or technology serving the facility;
  - iii. Change the position and design of any outlet at the point or points of discharge of effluents; or
  - iv. Affect any other change outlined in 20(3) of the Environmental Protection (Authorisations) Regulations.
- 1.2 The Permit Holder shall construct camps, roads, log markets, plumbed toilets/pit latrines, and trail(s) in the manner specified in the Guyana Forestry Commission (GFC) Guidelines for Forest Operations, 2018.
- 1.3 The Permit Holder shall ensure that adequate provisions are in place for ingress to and egress from the Project site.
- 1.4 Where the land surface has been disturbed during/after construction, expansion, modification, or repair of the operation or any portion of the operation, the Permit Holder shall reclaim/rehabilitate the surface of the land to its former state; except where it is not possible, the Permit Holder may reclaim and/or rehabilitate unused land to an equivalent standard.
- 1.5 The Permit Holder shall discharge logs safely through the use of appropriate equipment i.e., a log extractor at log market/s to ensure logs do not free fall from haulers to the ground, resulting in vibration and excessive damage to soils and/ or vegetation.
- 1.6 The Permit Holder shall prohibit the hunting, trapping, and trading of endangered and locally protected wildlife species. Further, prohibit the capture, trading, and removal of wildlife by employees and/or all third-party contractors.

## **2.0 EMPLOYEES**

- 2.1 The Permit Holder shall comply with the requirements of the **Occupational Safety and Health Act, Cap. 99:01, Laws of Guyana.**
- 2.1.1 Provide employees with the necessary protective equipment to fit their job specifications.

- 2.1.2 Provide first aid kit/s equipped according to the Guyana Red Cross standards which shall include a snake bite kit.
- 2.1.3 Provide communication and transportation systems to respond to emergencies.
- 2.2 The Permit Holder shall make all employees/third-party contractors aware of the Conditions of the Environmental Permit and provide training on good environmental management practices. A training report shall be kept and submitted upon the Officers' request during a Compliance Inspection.

### **3.0 WASTE MANAGEMENT**

#### **Comply with the provisions of the Environmental Protection (Litter Enforcement) Regulations, 2013.**

- 3.1 The Permit Holder shall maintain good housekeeping, sanitary and hygienic practices, and the good aesthetic quality of your surroundings.
- 3.2 The Permit Holder shall promote proper solid waste management practices at the Project site. Provide covered garbage receptacles at strategic locations around Concession. All solid waste collected in these receptacles must be appropriately stored, until such time, for disposal in a solid waste pit. Reuse, recycle, and compost waste materials as far as practicable. Waste shall not be disposed of in or near the waterways.
- 3.3 The Permit Holder shall construct and maintain a Solid Waste Pit at least 100 metres away from waterways, above the water table, and lined with at least 1.5 metres of clay/loam material to avoid leachate entering the groundwater.
  - 3.3.1 Storm water should be diverted from the waste pits. Pits should be maintained and covered on a regular basis to avoid fly and rodent infestations, as well as, mal-odours from leachate.
  - 3.3.2 When the maximum capacity is reached, the solid waste pit should be covered with at least 0.3 metres of soil, and a suitable site determined for another.
- 3.4 The Permit Holder shall ensure wood waste such as sawdust, wood ends, etc. is recovered and reused as landfill material where practical.



#### **4.0 AIR QUALITY AND NOISE MANAGEMENT**

**Comply with the Environmental Protection (Air Quality) Regulations, 2000, and the Environmental Protection (Noise Management) Regulations, 2000.**

4.1 The Permit Holder shall comply with the Guyana National Bureau of Standards (GNBS) Guidelines for noise emission into the environment, not exceeding the limits below at a distance of 15m (50 ft) from the source or property boundary, whichever is closer.

- **Industrial Limits: 100 dB** (Day-time (06:00 h - 18:00 h))

4.2 The Permit Holder shall ensure all equipment and machinery are placed on foundations properly designed to ensure effective damping of vibrations.

4.3 The Permit Holder shall implement all possible measures such as ensuring equipment is serviced and operated according to the manufacturer's recommendations to minimise the impact of sound levels on the environment.

4.4 The Permit Holder shall ensure that mechanical equipment and vehicles are regularly maintained and work at their optimal levels to minimise atmospheric emissions.

#### **5.0 HAZARDOUS MATERIALS**

**Comply with the provisions of the Environmental Protection (Hazardous Wastes Management) Regulations, 2000.**

5.1 There shall be no release of any pollutants (i.e., fuel, waste oil, wood preservatives) to groundwater or soil from permitted installation. Accidental release of pollutants to soil and groundwater must be recorded and reported **within 24 hrs** to the Agency for further investigation.

5.2 Take the necessary precautionary measures such as the use of leak-proof and tightly closed containers during the transport of fuel to the concession. Appropriate measures should also be taken during the handling and use of all Hazardous Waste at the concession.

5.3 Store fuel and waste oil in tightly covered plastic drums/pails to avoid spillage. Where possible, ensure it is stored on an impervious surface. It is an offence to drain fuel/lubricants including waste oils of any quantity from equipment onto the ground, drains, or waterways.

5.4 The Permit Holder shall promote the reuse of waste oil, for example,

lubrication of equipment, where practical.

- 5.5 The Permit Holder shall label and store before being reused or sold to an authorised dealer; waste oil, used batteries, oily rags, filters, and oil containers, in a designated area with an impervious surface.

## **6.0 COMPLIANCE MONITORING AND REPORTING**

- 6.1 The Permit Holder shall comply with any lawful directions given by the EPA from time-to-time in furtherance of the implementation of any international or other obligation for the environmental protection of Guyana.
- 6.2 The Permit Holder shall monitor the implementation of the Conditions of this Environmental Permit, insofar as they involve adherence by your employees and all third parties under your direction.
- 6.3 The Permit Holder shall submit to the EPA, the **Environmental Annual Reports** on the status of the project, progress of the implementation of the monitoring activities and compliance with the conditions contained herein by **March 31** every year.
- 6.4 The Permit Holder shall conform to all terms and conditions under which this Environmental Permit is granted and the Permit Holder shall be liable for any loss or damage that arises from the project as a result of the Permit Holder's activities or breach of any term or condition of this Permit.
- 6.5 The Permit Holder shall inform the Agency prior to or within **thirty (30) days** of any change of name or ownership of the operation.
- 6.6 The Permit Holder shall notify the Agency **within twenty-one (21) days** in event of death, bankruptcy, liquidation or receivership of the Permit Holder or if the Company becomes a party to an amalgamation.
- 6.7 The Permit Holder shall notify the EPA **within one (1) hour** of the occurrence of any environmental emergencies such as a sudden onset disaster, accident, natural, technological or human-induced factors that cause or threaten to cause severe environmental damage as well as harm to human health or livelihood.
- 6.8 The Permit Holder shall report to the Agency any non-compliance with the Environmental Permit () as follows:
- 6.8.1 Within **twenty-four (24) hours** of the time the Permit Holder becomes aware of the non-compliance, the anticipated manner in which it may endanger human health or the environment.

- 6.8.2 Within **seventy-two (72) hours**, submit to the Agency a written report containing a description of the non-compliance, its cause, and the period of non-compliance including exact dates and time.
- 6.8.3 Submit a report to the Agency indicating the reasons and the anticipated time it is expected to continue if the non-compliance has not been corrected.

**7.0 INSTITUTIONAL AUTHORITY/LIABILITIES**

- 7.1 The Permit Holder shall be liable for any material environmental harm caused by polluting the environment, pursuant to s. 39 of the Environmental Protection Act, Cap. 20:05, Laws of Guyana.
- 7.2 The Permit Holder shall be liable for any activity that causes or is likely to cause pollution of the environment unless all reasonable and practicable measures are taken to prevent or minimise any resulting adverse effect, pursuant to s. 19 of the Environmental Protection Act, Cap. 20:05, Laws of Guyana.
- 7.3 The Permit Holder shall be liable for discharging, causing or permitting the entry into the environment, of any contaminant in any amount, concentration or level excess of that prescribed by the regulations or stipulated by this Environmental Permit (Renewed), pursuant to s. 19 of the Environmental Protection Act, Cap. 20:05, Laws of Guyana.
- 7.4 The Permit Holder shall be liable to compensate any person who suffers any loss or damage as a result of contravening conditions 7.2 and 7.3 of this Environmental Permit, pursuant to s. 19 of the Environmental Protection Act, Cap. 20:05, Laws of Guyana.
- 7.5 The Permit Holder shall not be indemnified by the Agency for any activity that causes or is likely to cause pollution to the environment, resulting from adverse effects through the discharge, any contaminant in any amount, concentration, ultra-hazardous substances, chemicals or otherwise, and shall be rendered liable to prosecution and to penalties prescribed under the Environmental Protection Act and Regulations.
- 7.6 The Permit Holder shall be liable of any gross negligence or willful misconduct caused by the Permit Holder, his Servants and/or Agents, to the environment, biodiversity, protected species and natural habitat with respect to any release, discharge, or spill, of contaminant fluids, oil or lubricants.
- 7.7 Should the Permit Holder contravene or be likely to contravene any condition of this Permit, the Agency (EPA) may serve on him an

Enforcement Notice in accordance with Section 26 of the Environmental Protection Act, Cap. 20:05, Laws of Guyana.

- 7.8 Where it appears to the Agency that the Permit Holder is engaged in any activity that may pose a serious threat to natural resources or the environment, or a risk of serious pollution of the environment or any damage to public health, the EPA may issue to the Permit Holder a Prohibition Notice, which may order him to immediately cease the offending activity, in accordance with Section 27 of the Environmental Protection Act, Cap. 20:05, Laws of Guyana.
- 7.9 The EPA reserves the right to conduct regular inspections of the Permit Holder's activities as part of its monitoring and enforcement requirements under the Environmental Protection Act, Cap 20:05, the Environmental Protection (Amendment) Act, 2005, and Environmental Protection (Authorisations) Regulations, 2000.
- 7.10 The Permit Holder, His Servants and/or Agents shall at all times, allow entry to the permitted facility to any Officer designated by the EPA for the purposes of conducting inspections or any other legitimate business of the Agency. Pursuant to Section 38 of the Environmental Protection Act, Cap. 20:05, Laws of Guyana, it is an offence to assault, obstruct or hinder an authorised person in the execution of his/her duty under the said Act or its Regulations and the Permit Holder shall be liable to penalties prescribed under paragraph (c) of the Fifth Schedule for doing so.
- 7.11 The EPA has the right to modify, cancel or suspend this Permit for breach of any of the terms and conditions contained herein.
- 7.12 **This Environmental Permit is not the final consent; all relevant Permissions should be obtained from other regulatory bodies for continued operation.**
- 7.13 This Environmental Permit is effective for the period stipulated herein; **January 2025 to December 2027.**
- 7.14 This Environmental Permit shall remain valid until **December 31, 2027**, unless otherwise suspended, cancelled, modified or varied, in accordance with the provisions of this Permit or the Environmental Protection Act, Cap. 20:05, Laws of Guyana, Environmental Protection (Amendment) Act, 2005, and the Environmental Protection (Authorisations) Regulations, 2000.
- 7.15 This Permit must be renewed by submitting a completed Application Form for Renewal of Environmental Authorisation to the Agency at least six months before this Permit expires, that is, no later than **June 30, 2027.**

Issued under the Environmental Protection Act, Cap. 20:05, Laws of Guyana, the Environmental Protection (Amendment) Act, 2005, and the Environmental Protection (Authorisations) Regulations, 2000.

- 7.16 Any late submission of renewal application (s) after the specified date as stated above, may require the Permit Holder to pay, in addition to the renewal fee, a late penalty fee (accruing at the time such obligation was first owed for renewal) at a rate of **two thousand dollars (GY\$2000.00) per day for every business day late**, until such renewal application is submitted to the Agency, without prejudice to any other rights of the Permit Holder in connection therewith.
- 7.17 Failure to comply with the requirements of this Permit or with applicable laws and regulations, whether existing or forthcoming, shall render the Permit Holder liable to prosecution and to penalties, inclusive of civil penalties, injunctive relief and imprisonment, as prescribed under the Environmental Protection Act, Cap. 20:05, Laws of Guyana, the Environmental Protection Regulations and other applicable Laws of Guyana.
