# **Environmental Permit (Renewed & Modified)**

**Issued under the Environmental Protection Act, Cap. 20:05, Laws of Guyana, the Environmental Protection (Amendment) Act, 2005, and the Environmental Protection (Authorisations) Regulations, 2000**

Sean's Transportation Service Inc, hereinafter referred to as the "Permit Holder", is hereby authorised in accordance with the Environmental Protection Act, Cap. 20:05, the Environmental Protection (Amendment) Act, 2005, and the Environmental Protection (Authorisations) Regulations, 2000, to Collect and Transport Solid (Food) Waste From Seacor Marine to Haags Bosch Sanitary Landfill, hereinafter referred to as the "Project", in a manner indicated in the Renewal Application for Environmental Authorisation submitted on October 4, 2023, and subject to the terms and conditions set forth herein under the Environmental Protection Act, Cap. 20:05, Laws of Guyana, existing and/or forthcoming Regulations made under the said Act, and/or any applicable laws, guidelines, best practices, and standards relevant to this project.

**This is a Renewal and Modification Environmental Permit Ref. #: 20210903 - SYTGW issued on February 03, 2023, and expired on December 31, 2023.**

**The Permit Holder, His Servants, Agents, and/or Sub- Contractors shall comply with the following Terms and Conditions for Operation:**

## **1.0 GENERAL OPERATION**

- 1.1 Make an application to the Agency to vary this Permit in instances where it becomes necessary to:
  - i. change the construction, operation, structure, or layout of the facility and all associated buildings;

- ii. change equipment, machine, apparatus, mechanism, system, or technology serving the facility;
  - iii. change the position and design of any outlet at the point or points of discharge of effluents; or
  - iv. effect any other change outlined in 20(3) of the Environmental Protection (Authorisations) Regulations.
- 1.2 Standard Operating Procedures (SOPs) for safe collection and transportation of non-hazardous solid wastes shall be maintained.
- 1.3 All employees shall be trained on these SOPs outlined in **condition 1.2**. An Annual training schedule shall be kept and submitted to the EPA upon request.
- 1.4 All employees, and third parties under the Project's direction, shall be made aware of the conditions of the Environmental Authorisation.
- 1.5 Adhere to the requirements of the **Occupational Safety and Health Act, Cap: 99:01**, Laws of Guyana.

#### **COLLECTION OF NON-HAZARDOUS SOLID WASTES**

- 1.6 Collection and disposal of hazardous waste is **strictly prohibited**.
- 1.7 All waste collection and transportation shall be in accordance with the Transportation Plan submitted to the EPA on **October 06, 2021**.
- 1.8 Non-hazardous solid wastes collected shall be disposed of at Haags Bosch Sanitary Landfill.
- 1.9 Emergency spill cleanup kits shall be maintained on the Waste Collection Vehicles for response to potential spills. Kits should contain absorbent materials, drain seals, and other appropriate tools for clean-up.
- 1.10 Waste Collection Vehicles shall at all times be parked on an impervious base to prevent leaks and spills of leachate into the soil.
- 1.11 The Waste Collection Vehicles shall be equipped with the following:
- i. A metal tailgate to cover the hopper and compactor which shall be powered by a hydraulic or electric system.
  - ii. A sump or drip pan made of anti-corrosive materials to collect leachate discharged from the compactor and hopper.
- 1.12 Waste Collection Vehicles shall be inspected for signs of leakage or corrosion and



- damaged parts **must be** repaired/replaced **immediately**. Inspection reports must be maintained and submitted to the EPA upon request.
- 1.13 Highly visible and legible labels shall be affixed to the Waste Collection Vehicles and shall include the following information:
- i. Identity and contact information of the Project
  - ii. The words **“Solid Waste Disposal Service”**
- 1.14 The Project shall maintain all records of the locations (i.e., the location from which waste is obtained and the location at which waste is disposed of), number of trips per day, and the quantity of per trip of non-hazardous wastes that are collected, transported, and disposed of. The registered information shall be made available for inspection by the EPA upon request.

## **2.0 AIR & NOISE QUALITY**

- 2.1 Adhere to the provisions of the **Environmental Protection (Air Management) Regulations 2000 and Environmental Protection (Noise Management) Regulations, 2000.**
- 2.2 Waste Collection Vehicles shall be parked on foundations designed to ensure effective damping of vibrations.
- 2.3 Waste Collection Vehicles capable of causing, or preventing, emissions shall be maintained in accordance with the manufacturer's specification. The maintenance schedule for the truck shall be submitted to the Agency as part of the **Annual Report.**
- 2.4 The Best Environmental Practices or measures; e.g., mufflers, enclosures, or other appropriate devices, shall be utilized to mitigate adverse noise impacts from Waste Collection Vehicles on the environment.
- 2.5 Idling of transport vehicles shall be limited, as far as practical and vehicles switched off when not in use.

## **3.0 WATER QUALITY**

- 2.1 Adhere to the provisions of the **Environmental Protection (Water Quality) Regulations 2000.**
- 3.2 Spillage occurring during the collection of waste shall be **immediately** cleaned up and treated with chlorine prior to disposal.
- 3.3 Truck maintenance activities shall **NOT** be conducted at the waste disposal site to avoid soil and water contamination from fuel, grease, waste oils, and other petroleum products.



- 3.4 All Waste Collection Vehicles shall be decontaminated at a wash bay and wastewater collected and treated before disposal.
- 3.5 A Plan of the treatment processes applied to the wastewater before final discharge shall be submitted to the EPA by **January 31, 2024**.


#### **4.0 COMPLIANCE MONITORING AND REPORTING**

- 4.1 Notify the Environmental Protection Agency **within one (1) hour** of the occurrence of any environmental emergencies (e.g., oil spills, hazardous materials/wastes spill, sudden onset disaster, natural, technological, or human-induced factors that cause or threaten to cause severe environmental damage as well as harm to human health or livelihood).
- 4.2 Monitor the implementation of the conditions of this Permit, insofar as they involve adherence by your employees and all third parties under your direction.
- 4.3 Notify the Agency in writing of any change of name or ownership of the Permit Holder's facility within **thirty (30) days** after the change occurs.
- 4.4 Notify the Agency **within twenty-one (21) days** in the event of death, bankruptcy, liquidation, or receivership of the Permit Holder or if the Company becomes a party to an amalgamation.
- 4.5 Maintain and submit to the Agency records of the type, composition, and quantity of contaminant released (i.e. any solid, liquid, gas, odour, sound, vibration, radiation, heat, or combination of any of them).
- 4.6 Submit an **Annual Report** to the EPA on your compliance with this on or before **March 31, each year**.
- 4.7 Report to the Agency any non-compliance(s) with the Environmental Permit:
- i. Within **twenty-four (24) hours** of the time the Holder of the Environmental Authorisation becomes aware of the non-compliance outlining the anticipated manner in which human health or the environment may be impacted.
  - ii. Within **seventy-two (72) hours** of the time the Holder of the Environmental Permit becomes aware of the non-compliance, submit to the Agency a written report containing a description of the non-compliance, its cause, the period of non-compliance including exact dates and time and the anticipated time it is expected to continue if the non-compliance(s) has not been corrected.

- 4.8 Comply with any lawful directions given by the EPA from time-to-time in furtherance of the implementation of any international or other obligation for the environmental protection of Guyana.
- 4.9 It is the responsibility of the Permit Holder to ensure the permitted activity and premises are secured and that all practicable steps necessary to prevent fires, explosions, leaks, or suspected leaks and spills at the permitted premises are taken.

## **5.0 INSTITUTIONAL AUTHORITY/ LIABILITIES**

- 5.1 The Permit Holder shall be liable for any material environmental harm caused by polluting the environment, pursuant to s. 39 of the Environmental Protection Act, Cap. 20:05, Laws of Guyana.
- 5.2 The Permit Holder shall be liable for any serious environmental harm caused by polluting the environment, pursuant to s. 39 of the Environmental Protection Act, Cap. 20:05, Laws of Guyana.
- 5.3 The Permit Holder shall be liable for any activity that causes or is likely to cause pollution of the environment unless all reasonable and practicable measures are taken to prevent or minimize any resulting adverse effect, pursuant to s. 19 of the Environmental Protection Act, Cap. 20:05, Laws of Guyana.
- 5.4 The Permit Holder shall be liable for discharging, causing or permitting the entry into the environment, of any contaminant in any amount, concentration or level excess of that prescribed by the regulations or stipulated by this Environmental Permit (Renewed), pursuant to s. 19 of the Environmental Protection Act, Cap. 20:05, Laws of Guyana.
- 5.5 The Permit Holder shall be liable to compensate any person who suffers any loss or damage as a result of contravening conditions 5.3 and 5.4 of this Environmental Permit (Renewed) pursuant to s. 19 of the Environmental Protection Act, Cap. 20:05, Laws of Guyana.
- 5.6 The Permit Holder shall not be indemnified by the Agency for any activity that causes or is likely to cause pollution to the environment, resulting from adverse effects through the discharge, any contaminant in any amount, concentration, ultra hazardous substances, chemicals or otherwise, and shall be rendered liable to prosecution and to penalties prescribed under the Environmental Protection Act and Regulations.
- 5.7 The Permit Holder shall be liable of any gross negligence or willful misconduct caused by the Permit Holder, his Servants and/or Agents, to the environment, biodiversity, protected species and natural habitat with respect to any release, discharge, or spill, of contaminant fluids, oil or lubricants.





- 5.8 Should the Permit Holder contravene or be likely to contravene any condition of this Permit, the Agency (EPA) may serve on him an Enforcement Notice in accordance with Section 26 of the Environmental Protection Act, Cap. 20:05, Laws of Guyana.
- 5.9 Where it appears to the Agency that the Permit Holder is engaged in any activity that may pose a serious threat to natural resources or the environment, or a risk of serious pollution of the environment or any damage to public health, the EPA may issue to the Permit Holder a Prohibition Notice, which may order him to immediately cease the offending activity, in accordance with Section 27 of the Environmental Protection Act, Cap. 20:05, Laws of Guyana.
- 5.10 The EPA reserves the right to conduct regular inspections of the Permit Holder's activities as part of its monitoring and enforcement requirements under the Environmental Protection Act, Cap 20:05, and the Environmental Protection (Amendment) Act, 2005, and Environmental Protection (Authorisations) Regulations, 2000.
- 5.11 The Permit Holder, His Servants and/or Agents shall at all times, allow entry to the permitted facility to any Officer designated by the EPA for the purposes of conducting inspections or any other legitimate business of the Agency. Pursuant to Section 38 of the Environmental Protection Act, Cap. 20:05, Laws of Guyana, it is an offence to assault, obstruct or hinder an authorised person in the execution of his/her duty under the said Act or its Regulations and the Permit Holder shall be liable to penalties prescribed under paragraph (c) of the Fifth Schedule for doing so.
- 5.12 The EPA has the right to modify, cancel or suspend this Permit for breach of any of the terms and conditions contained herein.
- 5.13 This Environmental Permit is not the final consent; all relevant Permissions should be obtained from other regulatory bodies for continued operation.
- 5.14 This Environmental Permit is effective for the period stipulated herein; **November 2023 to October 2028.**
- 5.15 This Environmental Permit shall remain valid until **October 31, 2028**, unless otherwise suspended, canceled, modified, or varied, in accordance with the provisions of this Permit or the Environmental Protection Act, Cap. 20:05, Laws of Guyana, Environmental Protection (Amendment) Act, 2005, and the Environmental Protection (Authorisations) Regulations, 2000.
- 5.16 This Permit must be renewed by submitting a completed Renewed Application Form for Environmental Authorisation to the Agency at least six months before this Permit expires, that is, no later than **April 30, 2028.**
- 5.17 Any late submission of renewal application (s) after the specified date as stated above, the agency may require the Permit Holder to pay, in addition to renewal fee,

a late penalty fee (accruing at the time such obligation was first owed for renewal) at a rate of **two thousand dollars (GY\$2000.00) per day for every business day late, until such renewal application is submitted to the Agency**, without prejudice to any other rights of the Permit Holder in connection therewith.

- 5.18 Failure to comply with the requirements of this Permit or with applicable laws and regulations, whether existing or forthcoming, shall render the Permit Holder liable to prosecution and to penalties, inclusive of civil penalties, injunctive relief and imprisonment, as prescribed under the Environmental Protection Act, Cap. 20:05, Laws of Guyana, the Environmental Protection Regulations and other applicable Laws of Guyana.
