Environmental Permit (Varied)

Issued under the Environmental Protection Act, Cap. 20:05, Laws of Guyana, the Environmental Protection (Amendment) Act, 2005, and the Environmental Protection (Authorisations) Regulations, 2000.

Demerara Shipping Company Limited, herein referred to as the "Permit Holder", is hereby authorised in accordance with the Environmental Protection Act, Cap. 20:05, Laws of Guyana, Environmental Protection (Amendment) Act, 2005, and the Environmental Protection (Authorisations) Regulations, 2000, to construct and operate a wharf located at Lot 6-12, Water and Schumaker Streets, Georgetown, and the relocation of two above-ground fuel tanks with capacities 5045.98 L and 5561.45 L respectively, to a site within the above-stated location, hereinafter referred to as "the Project", in the manner indicated in the Application for Renewal of Environmental Authorisation dated October 06, 2021, subject to the terms and conditions set forth herein under the Environmental Protection Act, existing or forthcoming regulations made under the said Act and/or any other applicable Laws of Guyana, best practices, guidelines and standards relevant to this project.

This is a Variance of the Environmental Permit, Reference # 20160427-DSCLW, issued on July 14, 2022, which will expire on June 30, 2027. This Environmental Permit (Varied) is issued pursuant to the Environmental Protection (Authorisations) Regulations, 2000.

1.0 GENERAL

Environmental Permit (Varied) - Ref. No.: 20160427-DSCLW

Issued under the Environmental Protection Act, Cap. 20:05, Laws of Guyana, the Environmental Protection (Amendment) Act, 2005, and the Environmental Protection (Authorisations) Regulations, 2000.

- 1.1 Make an application to the Agency to vary this Environmental Permit (Renewed) in instances where it becomes necessary to:
 - i. Change the construction, operation, structure, or layout of the facility and all associated buildings;
 - ii. Change equipment, machine, apparatus, mechanism, system, or technology serving the facility;
 - iii. Change the position and design of any outlet at the point or points of discharge of effluents; or
 - iv. Affect any other change outlined in 20(3) of the Environmental Protection (Authorisations) Regulations.
- 1.2 Adhere to requirements of the **Occupational Health and Safety Act, Cap 99:10, Laws of Guyana.**
- 1.3 Make all employees, and third parties under your direction, aware of the conditions of the Environmental Authorisation and provide training on good environmental practices.
- 1.4 Maintain approval from the Guyana Fire Service and provide fire protection measures in accordance with this approval.
- 1.5 Construction works shall not be executed between 21:00 hrs. to 06:00 hrs. on any day, close to communal areas, unless approval is sought from the EPA. This requirement does not apply to large concrete pours or asphalt laying and earth removal, where work in the early morning and late evening maybe required.
- 1.6 Construction and operation of activities at the project site shall be in accordance with Maritime, Sea and River Defence and Drainage & Irrigation Laws of Guyana and any applicable guidelines.

2.0 WATER AND SOIL QUALITY MANAGEMENT

- 2.1 Strictly comply with the provisions of the **Environmental Protection (Water Quality) Regulations 2000.**
- 2.2 Monitoring of the parameters above shall be conducted in accordance with the approved monitoring plan, and the results shall be submitted to the Agency as part of the Annual Report.

Issued under the Environmental Protection Act, Cap. 20:05, Laws of Guyana, the Environmental Protection (Amendment) Act, 2005, and the Environmental Protection (Authorisations) Regulations, 2000.

- 2.3 Avoid erosion, siltation, and sedimentation of existing water bodies within the vicinity of the project site.
- 2.4 Install sediment controls along the site perimeter to receive sediments from surface runoff.
 - 2.4.1 Remove sediments before it accumulates to half of the above-ground height of the perimeter control.
- 2.5 Construct and maintain drainage systems capable of handling the probable maximum precipitation event.
- 2.6 Avoid soil and water contamination from fuel, grease, waste oils, and other petroleum products that might be used at the facility.
- 2.7 Store fuel in a secured designated area to prevent accidental release into the surrounding environment, especially in rainy conditions. The designated area should not be within 100 m of surrounding water bodies.
- 2.8 Store all chemicals in leak-proof containers that are kept under water-resistant cover and surrounded by secondary containment structures (e.g., spill berms, decks, spill containment pallets) to minimize the potential discharge of chemicals in stormwater and external waterways.

3.0 AIR QUALITY MANAGEMENT AND NOISE ABATEMENT

- 3.1 Strictly comply with the **Environmental Protection (Air Quality) Regulations, 2000**, and the **Environmental Protection (Noise Management) Regulations 2000**.
- 3.2 Monitor noise emissions in accordance with the approved ESMP to determine compliance with the **Guyana National Bureau of Standards (GNBS) Guidelines for Noise Emissions into the Environment**. Sound levels from noise-making devices shall not exceed the limits below, at a distance of 15 metres (50 ft) from the source or property boundary, whichever is closer.
 - **Construction Limits:** **90 dB** during the daytime (06:00 h - 18:00 h)
75 dB during the night-time (18:00 h - 06:00 h)
- 3.3 Locate generators away from communal areas to minimise adverse fumes/soot impacts on the contiguous areas.

- 3.4 Exhaust stacks of generators shall be at least 2 metres above the tallest building.
- 3.5 Monitor ambient air quality in accordance with the approved ESMP to determine compliance with the World Health Organisation (WHO) Air Quality Guidelines for Particulate Matter in the Environment, not exceeding the limits below:

PM_{2.5}: 25 µg/m³ 24-hour mean

PM₁₀: 50 µg/m³ 24-hour mean

- 3.6 Record, investigate and address complaints of excessive noise, dust and vibrations from the public promptly upon receipt. Maintain a record of all complaints received and the action taken.

4.0 FUEL TANK RELOCATION AND MANAGEMENT

- 4.1 Strictly adhere to the area designated for relocation, where all approvals from the Guyana Fire Service (GFS) and the Guyana Energy Agency (EA) should be updated where necessary. Copies of updated approvals should be submitted to the EPA upon receipt.
- 4.2 Prepare and submit a decommission plan of the old fuel tank storage area, with detailed information on all procedures in place to handle potential spills, storage of waste oil, handling of waste material including but not limited to residual fuel, contaminated piping and fittings, waste material from the wreckage of the containment bund.
- 4.3 At the new designated site, construct and maintain a fuel containment bund, which must have an impervious surface for the storage of all oils, lubricants, waste oils, and fuels. The containment bund must be able to provide a containment capacity of 110% of the total volume of the largest storage containers.
- 4.4 Ensure that all fuel is stored away from ignition sources and have 'No Smoking' signs posted where fuel is handled or stored.
- 4.5 Ensure that oil/fuel containment adsorbent materials are appropriately stored in slop tanks and disposed of in a manner approved by the EPA.
- 4.6 Ensure that an appropriate spill containment kit is located on-site. The kit should contain absorbent material, drain seals, disposal containers, and other appropriate tools to absorb spilled oil and other spilled liquids.

Issued under the Environmental Protection Act, Cap. 20:05, Laws of Guyana, the Environmental Protection (Amendment) Act, 2005, and the Environmental Protection (Authorisations) Regulations, 2000.

5.0 FUEL AND HAZARDOUS/WASTE MANAGEMENT

- 5.1 Strictly adhere to the provisions of the **Environmental Protection (Litter Enforcement) Regulations 2013** and the **Environmental Protection (Hazardous Waste Management) Regulations, 2000**.
- 5.2 Maintain good housekeeping, sanitary and hygienic practices, and the aesthetic quality of the surroundings at all times.
- 5.3 Promote proper solid waste management and disposal practices at the site, and place covered garbage receptacles at strategic locations around the site.
- 5.4 Dumping of waste into the surrounding environment is strictly prohibited. Waste, inclusive of waste oil and/or fuel, shall not be stored within 10 meters of any waterways.
- 5.5 Hazardous waste shall be treated and/or disposed by an EPA authorised Hazardous Waste Disposal Facility. All hazardous waste treatment and disposal shall be documented on a Waste Manifest Form, which shall be submitted to the EPA as a component of the **Annual Report**.
- 5.6 Conduct refuelling, oil changes, and maintenance of equipment on an impervious base.
- 5.7 Spill equipment shall be available and utilised for containing and mitigating spills from fuel, bitumen, waste oils, lubricants, curing compounds, concrete admixtures, paints, etc.
- 5.8 Designate an area for the storage of fuel, used oil, washing detergents, sanitisers, and other hazardous materials. Hazardous materials/ waste storage areas shall be clearly labelled and secured. The following warning signs shall be clearly posted:
 - 5.8.1 "Hazardous Waste Storage Area"
 - 5.8.2 Danger - "Authorised Personnel Only"
 - 5.8.3 No eating, drinking, or smoking
- 5.9 Hazardous waste shall be contained in banded/kerbed storage areas. These areas shall adhere to the following requirements:
 - 5.9.1 Be situated in low traffic areas;
 - 5.9.2 No interceptor drains shall be constructed; and
 - 5.9.3 Be banded to provide 110% containment of the largest volume of hazardous materials stored therein.

- 5.10 Hazardous waste shall be stored in containers appropriate for the waste stream; that is:
- 5.10.1 Sealed Plastic Containers
 - 5.10.1.1 Water-based waste
 - 5.10.2 Sealed Metal Containers
 - 5.10.2.1 Solvents and petroleum-based products
 - 5.10.2.2 Oil and oily absorbents
- 5.11 Hazardous waste/materials storage containers shall be inspected weekly for signs of leakage, deterioration, or corrosion, and damaged containers shall be replaced immediately. Inspection reports shall be maintained and signed by a qualified inspecting officer and his/her supervisor.
- 5.12 Ensure that the sewage disposal system is well-maintained on site.

6.0 COMPLIANCE MONITORING AND REPORTING

- 6.1 Strictly comply with any lawful directions given by the Agency from time-to-time in furtherance of the implementation of any international or other obligation for the environmental protection of Guyana.
- 6.2 Monitor the implementation of the conditions of this Environmental Permit (Renewed), insofar as they involve adherence by employees and all third parties under your direction.
- 6.3 Report to the Agency any non-compliance(s) with this Environmental Permit (Renewed):
- 6.3.1 Within **twenty-four (24) hours** of the time the Holder of this Environmental Permit (Renewed) becomes aware of the non-compliance, with the anticipated manner in which it may endanger human health or the environment may be impacted.
 - 6.3.2 Within **seventy-two (72) hours** of the time the Holder of the Environmental Permit (Renewed) becomes aware of the non-compliance, submit to the Agency a written report containing a description of the non-compliance, its cause, the period of non-compliance including exact dates and time and the anticipated time it is expected to continue if the non-compliance(s) has not been corrected.

Issued under the Environmental Protection Act, Cap. 20:05, Laws of Guyana, the Environmental Protection (Amendment) Act, 2005, and the Environmental Protection (Authorisations) Regulations, 2000.

- 6.4 Submit an **Environmental Annual Report** to the EPA on your compliance with this Environmental Permit (Renewed) on or before **March 31, each year**.
- 6.5 Notify the EPA within **twenty-four (24) hours** of the occurrence of any environmental emergencies (e.g., oil spills, hazardous materials/wastes spills, sudden onset disaster, natural, technological, or human-induced factors that cause or threaten to cause severe environmental damage as well as harm to human health or livelihood).
- 6.6 Notify the Agency in writing of any change of name or ownership of the Permit Holder's facility within **thirty (30) days** after the change occurs.
- 6.7 Notify the Agency within **twenty-one (21) days** in the event of death, bankruptcy, liquidation, or receivership of the Permit Holder or if the Company becomes a party to an amalgamation.
- 6.8 It is the responsibility of the Permit Holder to ensure the permitted activity and premises are secured and that all practicable steps necessary to prevent fires, explosions, leaks, or suspected leaks and spills at the permitted premises are taken.

7.0 INSTITUTIONAL AUTHORITY/LIABILITIES

- 7.1 The Permit Holder shall be liable for any material environmental harm caused by polluting the environment, pursuant to **s. 39 of the Environmental Protection Act, Cap. 20:05, Laws of Guyana**.
- 7.2 The Permit Holder shall be liable for any serious environmental harm caused by polluting the environment, pursuant to **s. 39 of the Environmental Protection Act, Cap. 20:05, Laws of Guyana**.
- 7.3 The Permit Holder shall be liable for any activity that causes or is likely to cause pollution of the environment unless all reasonable and practicable measures are taken to prevent or minimize any resulting adverse effect, pursuant to **s. 19 of the Environmental Protection Act, Cap. 20:05, Laws of Guyana**.
- 7.4 The Permit Holder shall be liable for discharging, causing or permitting the entry into the environment, of any contaminant in any amount, concentration or level in excess of that prescribed by the regulations or stipulated by this Environmental Permit (Renewed), pursuant to **s. 19 of the Environmental Protection Act, Cap. 20:05, Laws of Guyana**.

- 7.5 The Permit Holder shall be liable to compensate any person who suffers any loss or damage as a result of contravening conditions 7.3 and 7.4 of this Environmental Permit (Renewed), pursuant to **s. 19 of the Environmental Protection Act, Cap. 20:05, Laws of Guyana.**
- 7.6 The Permit Holder shall not be indemnified by the Agency for any activity that causes or is likely to cause pollution to the environment, resulting from adverse effects through the discharge, any contaminant in any amount, concentration, ultra-hazardous substances, chemicals or otherwise, and shall be rendered liable to prosecution and to penalties prescribed under the Environmental Protection Act and Regulations.
- 7.7 The Permit Holder shall be liable for any gross negligence or wilful misconduct caused by the Permit Holder, his Servants and/or Agents, to the environment, biodiversity, protected species, and natural habitat with respect to any release, discharge, or spill of contaminant fluids, oil, or lubricants.
- 7.8 Should the Permit Holder contravene or be likely to contravene any condition of this Permit, the Agency (EPA) may serve on him an Enforcement Notice in accordance with **Section 26 of the Environmental Protection Act, Cap. 20:05, Laws of Guyana.**
- 7.9 Where it appears to the Agency that the Permit Holder is engaged in any activity that may pose a serious threat to natural resources or the environment, or a risk of serious pollution of the environment or any damage to public health, the EPA may issue to the Permit Holder a Prohibition Notice, which may order him to immediately cease the offending activity, in accordance with **Section 27 of the Environmental Protection Act, Cap. 20:05, Laws of Guyana.**
- 7.10 The EPA reserves the right to conduct regular inspections of the Permit Holder's activities as part of its monitoring and enforcement requirements under the Environmental Protection Act, Cap 20:05, the **Environmental Protection (Amendment) Act, 2005**, and **Environmental Protection (Authorisations) Regulations, 2000.**
- 7.11 The Permit Holder, His Servants and/or Agents shall at all times allow entry to the permitted facility to any Officer designated by the EPA for the purposes of conducting inspections or any other legitimate business of the Agency. Pursuant to **Section 38 of the Environmental Protection Act, Cap. 20:05, Laws of Guyana**, it is an offence to assault, obstruct or hinder an authorised person in the execution of his/her

duty under the said Act or its Regulations, and the Permit Holder shall be liable to penalties prescribed under paragraph (c) of the Fifth Schedule for doing so.

- 7.12 The EPA has the right to modify, cancel, or suspend this Permit for breach of any of the terms and conditions contained herein.
- 7.13 **This Environmental Permit (Varied) is not the final consent; all relevant Permissions shall be obtained from other regulatory bodies before commencing construction activities.**
- 7.14 This Environmental Permit (Varied) is effective for the period stipulated herein, **June 2022 to May 2027.**
- 7.15 This Environmental Permit (Varied) shall remain valid until **May 31, 2027**, unless otherwise suspended, cancelled, modified or varied, in accordance with the **Environmental Protection Act, Cap. 20:05, Laws of Guyana, Environmental Protection (Amendment) Act, 2005, and the Environmental Protection (Authorisations) Regulations, 2000.**
- 7.16 This Environmental Permit (Varied) shall be renewed by submitting “an Application for Renewal of Environmental Authorisation to the Agency at least six (6) months before this Permit expires, that is, no later than **November 30, 2026.**
- 7.17 Any late submission of renewal application(s) after the specified date as stated above, may require the Permit Holder to pay, in addition to renewal fees, a late penalty fee (accruing at the time such obligation was first owed for renewal) at a rate of **two thousand dollars (GY\$2000.00) per day for every business day late**, until such renewal application is submitted to the Agency, without prejudice to any other rights of the Permit Holder in connection therewith.
- 7.18 Failure to comply with the requirements of this Permit or with applicable laws and regulations, whether existing or forthcoming, shall render the Permit Holder liable to prosecution and to penalties, inclusive of civil penalties, injunctive relief, and imprisonment, as prescribed under the **Environmental Protection Act, Cap. 20:05, Laws of Guyana**, the Environmental Protection Regulations, and other applicable Laws of Guyana.
